

# 2017 Deschutes County Fair & Rodeo 4-H/FFA Dry Camping

## RULES & REGULATIONS

- The cost for a camp site on the grass, behind the animal barns, August 2nd through August 6<sup>th</sup>, 2017 is **\$125.00**. To reserve a camping site, please fill out the 4-H/FFA camper application form and return it to Deschutes County Fair, 3800 SW Airport Way, Redmond, OR 97756, along with a check for \$125.00. **Applications are accepted in person only, first come first serve. No applications by mail or email will be accepted.** Make checks payable to: **DC Fair & Expo.** **PLEASE NOTE: camping fee does NOT include admission into the Fair;** Day or Season passes MUST be purchased separately and are available at the Fair Administration Office.
- All motor homes/campers must be self-contained. There is no power or water available at these sites. If you need power and water you can make your reservation at the Expo Center RV Park. They have full hook-ups, laundry, showers, and restrooms. The cost is \$37.67 (includes taxes) per night and **MUST** be reserved by calling the Expo Center RV Park **DIRECTLY** at 541-585-1569. Reservations at the Expo Center RV Park can be made a year in advance.
- Due to limited space, **ONLY** 4-H & FFA members, parents, superintendents, and open class livestock exhibitors and superintendents will be allowed to camp behind the barns. All others must camp in the Expo Center RV Park.
- Due to the large number of requests for camping sites, all spaces will be assigned on a first-come, first-serve basis only. You may request a camping site, however the Fair cannot guarantee that you will receive the site that you requested.
- Applications **WILL NOT BE ACCEPTED UNTIL Wednesday, April 19, 2017.** If you are **planning on camping in a group or with other members of your club, ONE member must submit in person ALL of the applications together.**
- Absolutely NO cars or trucks are allowed next to the camp site. Vehicles **MUST** park in the exterior lots.
- **NO MOTORIZED VEHICLES (EXCEPT DESIGNATED STAFF) WILL BE ALLOWED ON THE FAIRGROUNDS, i.e. GOLF CARS, SCOOTERS, ATV'S ETC. THIS RULE WILL BE STRICTLY ENFORCED!!!**
- Dogs, bikes, skateboards, roller-skates, alcohol and tobacco are **NOT ALLOWED** in the RV Camping area or on the Fairgrounds!!!
- Please be sure to mark the appropriate size of the camping unit or RV on the application. Spaces are approximately 20' x 30'. If you have an RV that is larger than 40' it will be assigned to a special area.
- Once your application has been accepted and your space assigned, your permit will be mailed to you. Permits are typically mailed two weeks prior to Fair.

4-H/FFA RV/TENT APPLICATION FORM**

Each applicant is allowed only **ONE** space. You **CANNOT** purchase more than one space and you **CANNOT** purchase a space for someone else.

The Deschutes County Fair & Rodeo will not accept responsibility for damage incurred to the RV/tent while it is parked on the fairgrounds.

All youth exhibitors, under the age of 18, staying in the camping area must be with a parent or adult chaperone.

All parking permits must be affixed to the RV/tent in plain view.

The person signing the contract is responsible for picking up their own garbage. All camp sites must be clean upon departure.

**ONCE PARKED, RV/TENT MUST REMAIN IN PLACE FOR THE FIVE DAYS OF THE FAIR.** Camp sites will be available **after** 2:00 p.m., beginning Sunday, July 30<sup>th</sup>. **Campers will not be allowed to leave their space until after 5:00 p.m. Sunday, August 6th!!!!** RVs/tents must be in place no later than 8:00 pm, Tuesday, August 1, 2017. If a RV/tent is not in place by that time the Fair Management has the right to assign the space to another party.

**PENALTIES FOR VIOLATION OF RULES & REGULATIONS**

If the Rules & Regulations are not followed, the person signing this application will be held responsible for the actions of any or all persons staying in their assigned camp site.

Harassment of fellow campers and/or Fair personnel or violation of the Rules & Regulations may result in the applicant (and those they are responsible for) being asked to remove their RV/tent from the fairgrounds along with a recommendation not to issue a permit the following year.
