## State Shooting Sports Brings New Leaders to Deschutes County

The annual Master Shooting Sports Leader training event was held in Grants Pass during April 17<sup>th</sup> and 18<sup>th</sup> in Grants Pass, Oregon. Members of the Oregon State 4-H Shooting Sports team were on hand to train nearly 50 new Shooting Sports Leader from around the state in Archery, Shotgun, Pistol and Rifle. Tim McCormick of Jefferson County also provided a delicious Dutch oven dessert demonstration.

The annual event will bring two new Archery leaders to Deschutes County. Danny King and Chuck Gregory will be working with Deschutes County 4-H Archery Leader Brian Evans, but will now have the ability to split the archery group into multiple clubs as interest continues to grow.

Probably the biggest news was from State Outdoor Ed and Rec, David White, who unveiled 15 new Oregon instructors will be going to Colorado for national training May 11-16. The addition of 14 new instructors will allow for regional trailing to occur with more frequency than once per year. Dave guesses that our group will be one of the largest contingents at the national training.

The national training will be held in Grand Junction, Colorado.

## Pentathlon Exceeds Expectations

Did you hear about the Pentathlon? Wow, what a great event. The newest event in 4-H fundraising, the South Valley Bank & Trust 4-H Sportsmen's Pentathlon brought together 11 teams (22 participants) for a day of Hunting, Fishing and Sporting activities, followed by an evening of dining and auctions.

The sunny Saturday, one of the warmest on record for March 20<sup>th</sup>, showcased a Fly Fishing Derby, 3-D Archery Shoot, Chukar Hunt, GPS Navigation Course and a Sporting Clays venue. All 22 participants competed in every event, with the two lowest team scores being discarded to create a team total for the overall competition.

Prizes were awarded for the overall championship team, as well as the venue winners for each event. At the end of the day Two Guys and a Dog (Dr. Tom Rhueben and Dustin Kersavage) ran away with the overall victories in the Sporting Clays, Archery and Live Hunt competition. The combined score totaled 300 (out of a possible 300) points. In the two events that the Two Guys didn't win, the team placed second, behind a team from Tualatin Valley Coffee in GPS and Team Keystone in Fishing.

The Banquet/Auction hosted by Brand 33 at Aspen Lakes was also incredible. The hosts pulled out all the stops providing a generous buffet-style meal of beef, salads, pasta and bread. Master of Ceremonies, RL Garrigus, primed the audience of nearly 80 for the silent auction while Auctioneer Ralph McNulty wowed the generous crowd through an oral auction.

The inaugural event generated nearly \$4000 for the Deschutes County 4-H, to provide programming and scholarship opportunities to all Deschutes County Youth.

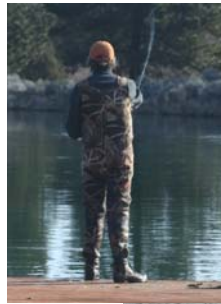

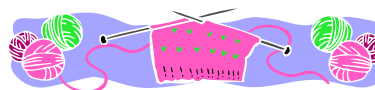

Deschutes county also hosted the event at the Deschutes County Fair & Expo in Redmond.

The intermediate teams made up of: Lauren Walley, Deborah Dial, Lindsay Soliz, Samantha Massingale, Lauren Curl, Tristan Cox, Region Hayden and Katie Cramer ended up 15th in horse bowl, 14th in judging and 8th in hippology.
